An act to amend Section 68120 of the Education Code, relating to public postsecondary education.

LEGISLATIVE COUNSEL'S DIGEST

SB 279, as amended, Chesbro. Public postsecondary education: excuse of tuition and fees.

Existing law requires the Regents of the University of California, the Board of Directors of the Hastings College of the Law, and the Trustees of the California State University to excuse the mandatory systemwide tuition and fees of any surviving spouse or surviving child, natural or adopted, of a deceased person who was a resident of the state, who was employed by a public agency, as defined, whose principal duties consisted of active law enforcement service or active fire suppression and prevention, and who was killed in the performance of active law enforcement or active fire suppression and prevention duties. Until January 1, 2004, this provision also applies to the surviving spouse or surviving child of a person who died while performing these duties, and who was employed as a contractor, or as an employee of a contractor,

performing services for a public agency, as defined. This provision is applicable to the Regents of the University of California only if the regents, by resolution, make it applicable.

This bill would extend indefinitely the application of this provision to the surviving spouse or surviving child of a contractor, or an employee of a contractor, as defined, performing services for a public agency. The bill would require, however, that a surviving child of a contractor, or of an employee of a contractor, be enrolled as an undergraduate student at a campus of the University of California or the California State University and document that his or her annual income, including the value of any support received from a parent, does not exceed the national poverty level, as defined.

The bill would incorporate additional changes to Section 68120 of the Education Code proposed by AB 933, to become operative only if AB 933 and this bill take effect on or before January 1, 2004, and this bill is enacted last.

The people of the State of California do enact as follows:

- 4 68120. (a) Notwithstanding any other provision of law, no
- 5 mandatory systemwide fees or tuition of any kind shall be required
- 6 of or collected by the Regents of the University of California, the
- 7 Board of Directors of the Hastings College of the Law, or the
- 8 Trustees of the California State University from any surviving
- 9 spouse or surviving child, natural or adopted, of a deceased person
- 10 who met all of the following requirements:
- 11 (1) He or she was a resident of this state.
- 12 (2) He or she was employed by a public agency, or was a

- 15 (3) His or her principal duties consisted of active law

3 (4) He or she was killed in the performance of active law

8 prevention duties.

9 (b) Notwithstanding subdivision (a), a person who qualifies for
10 the waiver of mandatory systemwide fees and tuition under this
11 section as a surviving child of a contractor, or of an employee of
12 a contractor, who performed services for a public agency shall, in
13 addition to the requirements set forth in subdivision (a), meet both
14 of the following requirements:

15 (1) Enrollment as an undergraduate student at a campus of the
16 University of California or the California State University.

18 value of any support received from a parent, does not exceed the
19 national poverty level as defined in subdivision (c) of Section
20 66025.3.

6 of or collected by the Regents of the University of California, the
7 Board of Directors of the Hastings College of the Law, or the
8 Trustees of the California State University from any surviving
9 spouse or surviving child, ~~natural or adopted~~, of a deceased person
10 who met all of the following requirements:

12 (2) He or she was employed by a public agency, *or was a*

21 (3) “Surviving child” means a natural or adopted child of the
22 deceased person, or a stepchild living or domiciled with the
23 deceased person at the time of his or her death.

24 SEC. 3. Section 2 of this bill incorporates amendments to
25 Section 68120 of the Education Code proposed by both this bill
26 and AB 933. It shall only become operative if (1) both bills are
27 enacted and become effective on or before January 1, 2004, (2)
28 each bill amends Section 68120 of the Education Code, and (3)
29 this bill is enacted after AB 933, in which case Section 1 of this bill
30 shall not become operative.
