An act to add ~~Section 25752 to~~ and repeal Section 25305.2 of the Public Resources Code, relating to energy resources.

LEGISLATIVE COUNSEL'S DIGEST

AB 1585, as amended, Blakeslee. Renewable energy resources: State Energy Resources Conservation and Development Commission: reporting.

Existing law expresses the intent of the Legislature, in establishing the Renewable Energy Resources Program, to increase the amount of renewable electricity generated per year, so that it equals at least 17% of the total electricity generated for consumption in California per year by 2006.

Existing law requires the State Energy Resources Conservation and Development Commission (Energy Commission) to certify eligible renewable energy resources, to design and implement an accounting system to verify compliance with the renewables portfolio standard by retail sellers, and to allocate and award supplemental energy payments to cover above-market costs of renewable energy.

Existing law requires the Energy Commission to prepare an integrated energy policy report every 2 years. Existing law requires the report to contain an overview of major energy trends and issues

facing the state, including, but not limited to, supply, demand, pricing, reliability, efficiency, and impacts on public health and safety, the economy, resources, and the environment.

This bill would require the Energy Commission to ~~review~~ include in the integrated energy policy report to be adopted November 1, 2007, a review of the feasibility of increasing the target for the amount of electricity to be procured from eligible renewable energy resources to 33% by the year 2020, ~~and to report the results of the review to the Governor and Legislature by July 1, 2007 with the review including specified information.~~

The bill would provide that it shall only become operative if SB 107 of the 2005-06 Regular Session is also enacted and becomes operative on or before January 1, 2006.

3 25305.2. (a) In addition to the assessments required by
4 Section 25305, the public interest energy strategies portion of the
5 integrated energy policy report to be adopted November 1, 2007,
6 shall include a review of the feasibility of increasing the target
7 for electricity to be procured from an eligible renewable energy
8 resource, as defined in Section 399.12 of the Public Utilities
9 Code, to 33 percent by the year 2020. The review shall consider
10 and report on all of the following:

11 (1) The deliverability of electricity from eligible renewable
12 energy resources to end users and any needed additions or
13 upgrades to the transmission grid system.

14 (2) The potential impacts upon the rates of electrical
15 corporations and whether or not a renewable energy public
16 goods charge, as defined in Section 25741, is necessary to fund
17 the above-market costs of electricity generated from eligible
18 renewable energy resources.

19 (3) The progress made by electrical corporations and all other
20 retail sellers, as defined in Section 399.12 of the Public Utilities
21 Code, and local publicly owned electric utilities, as defined in
22 Section 9604 of the Public Utilities Code, toward meeting the
