An act to add Chapter 8 (commencing with Section 92700) to Part 57 of Division 9 of Title 3 of the Education Code, relating to public postsecondary education.

LEGISLATIVE COUNSEL'S DIGEST

AB 181, as amended, Logue. Public postsecondary education: Baccalaureate Degree Pilot Program: University of California.

Existing law establishes a system of public elementary and secondary schools operated by local educational agencies throughout the state. Existing law also establishes a system of public postsecondary education in this state that includes 3 segments: the California Community Colleges, the California State University, and the University of California.

This bill would express the intent of the Legislature to establish a pilot program with the goal of establishing a coordinated curriculum that enables students, *including, but not necessarily limited to, students who have earned college course credit through concurrent enrollment in high school and community college*, to earn a baccalaureate degree from a participating University of California campus within 3 years of graduating from a secondary school, at a total cost to the student that does not exceed \$20,000, excluding the cost of instructional materials and mandatory campus-based fees. The bill would authorize the

University of California to establish a Baccalaureate Degree Pilot Program that includes any campus of the University of California, any campus of the California Community Colleges that volunteers to participate, and any secondary educational institution that volunteers to participate. The bill would place specified conditions on the operation of the pilot program.

*The people of the State of California do enact as follows:*

1 SECTION 1. Chapter 8 (commencing with Section 92700) is

7 92700. It is the intent of the Legislature to establish a pilot  
8 program with the goal of establishing a coordinated curriculum  
9 that enables students, *including, but not necessarily limited to,*  
10 *students who have earned college course credit through concurrent*  
11 *enrollment in high school and community college,* to earn a  
12 baccalaureate degree from a participating University of California  
13 campus within three years of graduating from a secondary school,  
14 at a total cost to the student that does not exceed twenty thousand  
15 dollars (\$20,000), excluding the cost of instructional materials and  
16 mandatory campus-based fees.

17 92701. The University of California may establish a  
18 Baccalaureate Degree Pilot Program that includes any campus of  
19 the University of California, any campus of the California  
20 Community Colleges that volunteers to participate, and any  
21 secondary educational institution that volunteers to participate.

22 92702. Notwithstanding any other law, all of the following  
23 provisions shall apply to the operation of the pilot program:

24 (a) The number of advanced placement (AP) course credits that  
25 a participating high school pupil may earn is unlimited.

26 (b) The number of transfer credits that a participating high  
27 school pupil earns that may be accepted by the participating  
28 community college or University of California campus shall be  
29 unlimited, except as provided for in subdivision (h).

1 (c) A participating student may attend and earn college course  
2 credit at either his or her high school or at a participating  
3 community college, and the provisions of subdivision (c) of Section  
4 48800 shall not apply to a participating high school pupil.

5 (d) In order to earn college course credit under the pilot program  
6 for college-level coursework undertaken before graduation from  
7 high school, other than courses taken at a community college, a  
8 participating student shall earn a score of three or better on the AP  
9 examination for each college-level course.

10 (e) A participating student shall receive priority enrollment  
11 status at a participating community college, and be required to  
12 enroll at that community college either in the summer term or the  
13 fall semester immediately succeeding that pupil's graduation from  
14 high school.

15 (f) In order to remain in the pilot program, a participating student  
16 shall maintain a minimum grade point average determined by the  
17 participating institution that shall be at least 2.5 on a 4-point scale.

18 (g) A participating student shall ~~attend community college~~ *be*  
19 *a full time student*, shall take no less than 12 semester units each  
20 semester, and shall complete his or her associate of arts transfer  
21 degree in not more than two years from the date he or she enrolled  
22 at the community college.

23 (h) A participating University of California campus shall accept  
24 a minimum of 60 semester units earned by a participating student  
25 at either a high school or a community college pursuant to the pilot  
26 program.

27 (i) The mandatory systemwide fees and tuition and mandatory  
28 campus-based fees charged to a participating student shall not be  
29 increased during the first two academic years of his or her  
30 attendance at a University of California campus pursuant to the  
31 pilot program.

32 (j) Institutions participating in the pilot program may offer  
33 participating students summer internships for credit toward the  
34 pilot program.

35 (k) A participating student shall receive priority enrollment  
36 status at a participating University of California campus, and shall  
37 be required to enroll at that University of California campus either  
38 in the summer term or the fall semester immediately succeeding  
39 that ~~pupil's~~ *student's* completion of the required community college  
40 coursework.

1 (l) The bachelor's degrees awarded at the participating  
2 University of California campus to a participating student shall be  
3 limited to baccalaureate degrees in one or more of the following  
4 fields of study:  
5 (1) Science.  
6 (2) Technology.  
7 (3) Engineering.  
8 (4) Mathematics.  
9 92703. The requirements imposed on the University of  
10 California pursuant to Section 92702 shall only apply to the extent  
11 that the regents, by appropriate resolution, make them applicable.
