ASSEMBLY BILL

No. 1358

Introduced by Assembly Member Fong

An act to amend Section 76060.5 of the Education Code, relating to community colleges.

LEGISLATIVE COUNSEL'S DIGEST

AB 1358, as amended, Fong. Student body association: student representation fee.

Existing law authorizes the governing board of a community college district to authorize the students of a college to organize a student body association to encourage students to participate in the governance of the college and conduct any activities, including fundraising activities. Existing law authorizes the governing body of a student body association to order an election be held to establish a student representation fee of \$1 per semester, collected by officials of the community college at or before registration, and requires an affirmative vote of $\frac{2}{3}$ of the students voting in the election to establish the fee.

This bill would instead authorize the election to establish the *student representation* fee in the amount of \$2, would require an affirmative vote of a majority of the students voting in the election to establish the student representation fee, and would, for a student representation fee adopted on or after January 1, 2014, require \$1 of the \$2 student representation fee to be expended to establish and support the operations of an independent statewide community college student organization,

recognized by the Board of Governors of the California Community Colleges, with governmental affairs representatives to advocate before the Legislature and other state and local governmental entities. The bill would, for a student representation fee adopted before January 1, 2014, provide that the student body association shall retain *the* authority to continue to receive the \$1 student representation fee, and authorize the student body association to conduct an election to instead adopt a \$2 student representation fee, as described above. *The bill would also require preparation of a summary by a community college district describing the amount of student representation fees collected and expenditures of the proceeds of the student representation fee and the amount distributed to the Board of Governors of the California Community Colleges. The bill would require that the summary be presented at the community college district board meeting each year and posted to the district Internet Web site.* To the extent that this additional requirement would impose new collection duties on the community colleges, this bill would impose a state-mandated local program.

The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

This bill would provide that no reimbursement is required by this act for a specified reason.

Vote: majority. Appropriation: no. Fiscal committee: yes.
State-mandated local program: yes.

The people of the State of California do enact as follows:

1 SECTION 1. Section 76060.5 of the Education Code is
2 amended to read:
3 76060.5. (a) If a student body association has been established
4 at a community college as authorized by Section 76060, the
5 governing body of the association may order that an election be
6 held for the purpose of establishing a student representation fee
7 of two dollars (\$2) per semester. The election shall be held in
8 compliance with regulations of the Board of Governors of the
9 California Community Colleges and shall be open to all regularly
10 enrolled students of the community college. The affirmative vote
11 of a majority of the students voting in the election shall be
12 sufficient to establish the fee. However, the election shall not be

1 sufficient to establish the fee unless the number of students who
2 vote in the election equals or exceeds the average of the number
3 of students who voted in the previous three student body
4 association elections.

5 (b) The student representation fee authorized by this section
6 shall be collected by the officials of the community college,
7 together with all other fees, at the time of registration or before
8 registration and shall be deposited in a separate fiduciary fund
9 established per the California Community Colleges Budget and
10 Accounting Manual for student representation fees. The money
11 collected pursuant to this section shall be expended to provide ~~for~~
12 ~~the support of~~ *for* governmental affairs representatives *of local or*
13 *statewide student body associations* who may be stating their
14 positions and viewpoints before city, county, and district
15 governments, and before offices and agencies of the state
16 government.

17 (c) One dollar (\$1) of every two-dollar (\$2) fee collected shall
18 be expended to establish and support the operations of an
19 independent statewide community college student organization,
20 recognized by the Board of Governors of the California Community
21 Colleges, with governmental affairs representatives to advocate
22 before the Legislature and other state and local governmental
23 entities. This subdivision shall only apply to student representation
24 fees adopted on or after January 1, 2014.

25 (d) Notwithstanding subdivision (c), a student body association
26 that adopted a student representation fee before January 1, 2014,
27 shall retain *the* authority to continue to receive the one-dollar (\$1)
28 fee as authorized pursuant to this section as it read ~~prior to~~ *before*
29 January 1, 2014. The student body association may conduct an
30 election pursuant to subdivision (a) to adopt a revised student
31 representation fee. If an election conducted pursuant to subdivision
32 (a) establishes the revised student representation fee, then one
33 dollar (\$1) of every two-dollar (\$2) fee collected shall be expended
34 as described in subdivision (c).

35 (e) (1) The chief fiscal officer of the community college shall
36 have custody of the money collected pursuant to this ~~section~~
37 *section*, and the money shall be disbursed for the purposes
38 described above upon the order of the governing body of the
39 student body association. ~~The~~

1 (2) *The community college district shall annually prepare a*
2 *summary of all revenue collected from the student representation*
3 *fee and the expenditures of the proceeds of the student*
4 *representation fee. The summary shall include the amount*
5 *distributed to the Board of Governors of the California Community*
6 *Colleges each year. The summary shall be presented at the*
7 *community college district board meeting each year and posted*
8 *to the community college district Internet Web site.*

9 (3) *The community college district may retain a portion of the*
10 *fees collected and deposited pursuant to this section that is equal*
11 *to the actual cost of administering these fees up to, but not more*
12 *than, 7 percent.*

13 (f) *The student representation fee authorized by this section*
14 *may be terminated by a majority vote of the students voting in an*
15 *election held for that purpose. The election shall be called and held*
16 *in compliance with regulations of the Board of Governors of the*
17 *California Community Colleges and shall be open to all regularly*
18 *enrolled students of the community college.*

19 (g) *A student may, for religious, political, financial, or moral*
20 *reasons, refuse to pay the student representation fee established*
21 *under this section. The refusal shall be submitted in writing to the*
22 *community college officials at the time the student pays other fees*
23 *collected by the community college officials. The refusal shall be*
24 *submitted on the same form that is used for collection of fees as*
25 *provided by the community college, which, as determined by the*
26 *community college, shall be as nearly as practical in the same form*
27 *as a model form prescribed by regulations of the Board of*
28 *Governors of the California Community Colleges.*

29 SEC. 2. *No reimbursement is required by this act pursuant to*
30 *Section 6 of Article XIII B of the California Constitution because*
31 *a local agency or school district has the authority to levy service*
32 *charges, fees, or assessments sufficient to pay for the program or*
33 *level of service mandated by this act, within the meaning of Section*
34 *17556 of the Government Code.*
