ASSEMBLY BILL

An act to ~~amend Section 66302 of, and to add Section 66073 to,~~ to the Education Code, relating to postsecondary education.

LEGISLATIVE COUNSEL'S DIGEST

AB 1653, as amended, Weber. Postsecondary education: campus climate.

Existing law establishes the segments of postsecondary education in this state, including the University of California administered by the Regents of the University of California, the California State University administered by the Trustees of the California State University, the California Community Colleges administered by the Board of Governors of the California Community Colleges, and independent institutions of higher education.

This bill would require the board, the trustees, and the governing body of each independent institution of higher education, as defined, and encourage each University of California campus, to each generate a report once every biennium of the legislative session, commencing with the 2017–18 Regular Session, that includes specified information related to the respective institution's campus climate, as defined, post the report on the respective institution's Internet Web site, and submit the report to specified state bodies. For the purposes of the board's

report, the bill would require the board to request certain information from community college districts, and would provide that the board’s report shall be based on data available from participating community college districts. The bill would require the board, the trustees, and the governing body of each independent institution of higher education, and would encourage the regents, to create, review every 2 years thereafter, and, as necessary, update protocols, policies, and procedures regarding compliance with the federal Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act and the Violence Against Women Reauthorization Act of 2013.

~~Existing law requests the trustees, the regents, and the governing board of each community college district to adopt and publish policies on harassment, intimidation, and bullying to be included within the rules and regulations governing student behavior, as provided.~~

~~This bill would require the trustees and the governing board of each community college district, if they expend funds to support activities related to campus climate, as defined, to adopt and publish the above-described policies. By requiring community college districts to adopt and publish these policies, this bill would impose a state-mandated local program.~~

~~The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.~~

~~This bill would provide that, if the Commission on State Mandates determines that the bill contains costs mandated by the state, reimbursement for those costs shall be made pursuant to these statutory provisions.~~

The people of the State of California do enact as follows:

- 13 (3) New and recent administrative efforts to reduce student food
14 insecurity and student homelessness.
- 15 (b) The governing body of each independent institution of higher
16 education, as defined in subdivision (b) of Section 66010, shall
17 generate a report once every biennium of the legislative session,
18 commencing with the 2017–18 Regular Session, that shall include
19 all of the information specified in paragraphs (1) to (3), inclusive,
20 of subdivision (a) as to the institution.
- 21 (c) The Board of Governors of the California Community
22 Colleges, the Trustees of the California State University, and the
23 governing body of each independent institution of higher education,
24 as defined in subdivision (b) of Section 66010, are required, and
25 each University of California campus is encouraged, to each post
26 the respective report on its Internet Web site.
- 27 (d) The Board of Governors of the California Community
28 Colleges, the Trustees of the California State University, and the
29 governing body of each independent institution of higher education,
30 as defined in subdivision (b) of Section 66010, are required, and
31 the Regents of the University of California are encouraged, to
32 create, review every two years thereafter, and, as necessary, update
33 protocols, policies, and procedures regarding compliance with the
34 Jeanne Clery Disclosure of Campus Security Policy and Campus
35 Crime Statistics Act (20 U.S.C. Sec. 1092(f)) and the Violence
36 Against Women Reauthorization Act of 2013 (20 U.S.C. Sec.
37 1092(f)(8)).
- 38 (e) The Board of Governors of the California Community
39 Colleges shall request, but not require, the information specified
40 in paragraphs (1) to (3), inclusive, of subdivision (a) from

1 community college districts. The report of the board shall be based
2 on data available from participating community college districts.

3 (f) A report to be generated pursuant to this section shall be sent
4 to the Governor, the Attorney General, and the appropriate policy
5 committees of the Legislature.

6 (g) For purposes of this section, “campus climate” means a
7 measure of an individual’s experience within a learning
8 environment, specifically focusing on the current attitudes,
9 practices, policies, and behaviors of campus life that impact the
10 success and retention of all members of a campus community.
