An act to amend Sections 13109 and 13117 of the Elections Code, relating to elections.

LEGISLATIVE COUNSEL'S DIGEST

AB 3092, as introduced, Gallegos. Elections: order of ballot precedence: numbering of ballot measures.

Existing law sets forth the order of precedence in which offices and measures shall be listed on the ballot.

This bill would delete an obsolete reference to judge of the justice court.

Existing law permits the county elections official, in counties using a voting system, to vary the order of school, county, city, and district offices appearing on the ballot in order to allow for the most efficient use of space on the ballot.

This bill would also permit those county elections officials to vary the order of ballot measures submitted to the voters for those purposes.

Existing law requires that, commencing with the November 2, 1982, general election, all state measures in all elections at which state measures are submitted to a vote be numbered in a continuous sequence for a period of 20 years, recommencing with the number "1" at the completion of the 20-year cycle.

This bill would shorten that numbering cycle to a 10-year period, commencing with the November 3, 1998, general election.

3 the official certifying them for the ballot.

4 (o) In order to allow for the most efficient use of space  
5 on the ballot in counties that use a voting system, as  
6 defined in Section 362, the county elections official may  
7 vary the order of subdivisions (j), (k), (l), ~~and~~ (m), and  
8 (n) as well as the order of offices within these  
9 subdivisions. However, the office of State Superintendent  
10 of Public Instruction shall always precede any school,  
11 county, or city office.

12 SEC. 2. Section 13117 of the Elections Code is  
13 amended to read:

14 13117. (a) Commencing with the November ~~2, 1982~~  
15 3, 1998, general election, all state measures in all elections  
16 at which state measures are submitted to a vote of the  
17 voters shall be numbered in a continuous sequence,  
18 commencing with the number "1" and continuing in  
19 numerical sequence for a period of ~~20~~ 10 years from the  
20 year of commencement.

21 (b) At the completion of a ~~20-year~~ 10-year cycle, the  
22 numbering sequence shall recommence with the number  
23 "1" at the next election at which state measures are  
24 submitted to a vote of the voters.
