SENATE BILL

No. 1669

Introduced by Senator Costa

February 21, 1996

An act to add Section 22810.6 to the Government Code, relating to public employees.

LEGISLATIVE COUNSEL'S DIGEST

SB 1669, as amended, Costa. Public employees: health benefits.

The Public Employees' Medical and Hospital Care Act authorizes the California Association of Highway Patrolmen to offer a health benefit plan.

This bill would require 5 years of coverage in that plan as an active employee in order to participate after retirement, *except as specified. In addition, the bill would set forth health benefit plan eligibility requirements for specified annuitants and specified former members of the California State Police.*

The provision would only be applicable to persons first employed on and after January 1, 1994.

Vote: majority. Appropriation: no. Fiscal committee: yes. State-mandated local program: no.

The people of the State of California do enact as follows:

1 SECTION 1. Section 22810.6 is added to the
2 Government Code, to read:

3 22810.6. In order to be eligible after retirement to
4 participate in a health benefit plan offered by the
5 California Association of Highway Patrol pursuant to
6 Section 22790, an annuitant shall have been a member of
7 the California Highway Patrolmen Health Benefits Trust
8 for a minimum of five years as an active employee.

9 *An annuitant who has retired for disability before*
10 *becoming eligible for service retirement is eligible to*
11 *participate in a health benefit plan offered by the*
12 *California Association of Highway Patrolmen. An*
13 *annuitant who obtained a disability retirement after*
14 *becoming eligible for a service retirement is not eligible*
15 *to participate in a health benefit plan offered by the*
16 *California Association of Highway Patrolmen unless the*
17 *requirement of five years participation as an active*
18 *employee has already been met.*

19 *Former members of the California State Police are*
20 *eligible to participate in a health benefit plan offered by*
21 *the California Association of Highway Patrolmen.*
22 *Former members of the California State Police who*
23 *transferred to the California Highway Patrol, and who*
24 *retired before January 1, 2003, are exempt from the*
25 *five-year requirement. Any former member of the*
26 *California State Police who otherwise meets the*
27 *requirement of five years minimum participation as an*
28 *active employee in a health benefit program plan offered*
29 *by the California Association of Highway Patrolmen is*
30 *eligible to participate in such a plan after retirement.*

31 This section shall only apply to persons who first
32 became employees of the California Highway Patrol on
33 and after January 1, 1994.
