An act to make an appropriation in augmentation of Items 5460-001-0001, 6110-001-0890, 9840-001-0001, 9840-001-0494, and 9840-001-0988 of Section 2.00 of the Budget Act of 1996, relating to contingencies ~~or~~ emergencies, and deficiencies, to take effect immediately as an appropriation for the usual current expenses of the state.

LEGISLATIVE COUNSEL'S DIGEST

AB 1562, as amended, Committee on Budget. Budget Act of 1996: contingencies ~~or~~ emergencies, and deficiencies.

(1) The Budget Act of 1996 appropriated \$5,000,000 from the General Fund, unallocated special funds, and unallocated nongovernmental cost funds for expenditure for contingencies or emergencies upon written authorization from the Director of Finance.

This bill would appropriate ~~\$573,705,000~~ \$466,159,000, as scheduled, in augmentation of these Budget Act appropriations. This bill would authorize the Director of Finance to withhold authorization for the expenditure of

funds appropriated in the bill until preliminary estimates of potential deficiencies are verified.

(2) *The Budget Act of 1996 appropriated \$312,291,000 from the General Fund for the support of the Department of the Youth Authority.*

This bill would appropriate \$10,000,000 from the General Fund in augmentation of that appropriation, as a 6-month, interest-free loan to the Department of the Youth Authority to allow it to meet operational cash-flow needs resulting from delays in the department's recovery of reimbursements.

(3) *The Budget Act of 1996 appropriated \$74,665,252 from the Federal Trust Fund for the support of the State Department of Education.*

This bill would appropriate \$459,000 from the Federal Trust Fund in augmentation of that appropriation, for administrative costs of the department for mediation and fair hearing services in connection with designated special education programs for exceptional children.

(4) This bill would declare that it is to take effect immediately as a statute providing an appropriation for the usual current expenses of the state.

17 SEC. 2. *The sum of ten million dollars (\$10,000,000) is*
18 *hereby appropriated, as a loan, from the General Fund*
19 *for support of the Department of the Youth Authority in*
20 *augmentation of Item 5460-001-0001 of Section 2.00 of the*
21 *Budget Act of 1996 (Ch. 162, Stats. 1996). The purpose of*
22 *this loan is to allow the department to meet operational*
23 *cash-flow needs resulting from delays in the department's*
24 *recovery of reimbursements. Notwithstanding any other*
25 *provision of law, the loan authorized by this section shall*
26 *be repaid by the department no later than a date six*
27 *months after the date any funds under the loan are*
28 *initially made available to the department, except that*
29 *the department is not required to make any payment for*
30 *interest on the loan.*

31 SEC. 3. *The sum of four hundred fifty-nine thousand*
32 *dollars (\$459,000) is hereby appropriated from the*
33 *Federal Trust Fund, in augmentation of Item*
34 *6110-001-0890 of Section 2.00 of the Budget Act of 1996*
35 *(Ch. 162, Stats. 1996), for administrative costs of the State*
36 *Department of Education for mediation and fair hearing*
37 *services activities under special education programs for*
38 *exceptional children (Item 6110-161-0890, Sec. 2.00,*
39 *Budget Act of 1996). Notwithstanding any other*
40 *provision of law, the administrative expenses restrictions*

1 *set forth in Provision 1 of Item 6110-161-0890 of Section*
2 *2.00 of the Budget Act of 1996 do not apply to the*
3 *appropriation made by this section.*

4 *SEC. 4.* This act makes an appropriation for the usual
5 current expenses of the state within the meaning of
6 Article IV of the California Constitution and shall go into
7 immediate effect.
