SENATE BILL

No. 33

Introduced by Senator Peace

December 7, 1998

An act to amend Sections 307 and 308 of, to repeal and add Section 305 of, and to amend, repeal, and add Section 309.1 of, the Public Utilities Code, relating to public utilities.

LEGISLATIVE COUNSEL'S DIGEST

SB 33, as amended, Peace. Public Utilities Commission: president: advisers.

Existing law requires the members of the Public Utilities Commission to elect one of their number president of the commission and requires the president to preside at all meetings and sessions of the commission. Existing law authorizes the commission to appoint an attorney and an executive director to the commission, as specified, and requires the attorney and executive director to perform duties that the commission may require. Under existing law, the executive director is responsible for the commission's executive and administrative duties, including, but not limited to, directing the operations and affairs of the commission. Existing law authorizes the Governor to appoint one adviser for each member of the commission upon the

request of the commission member and prohibits the total number of advisers exempt from civil service from exceeding 5.

This bill would require the Governor to designate the president of the commission from among its members. The bill would require the president to direct the executive director, the attorney, and other staff of the commission, except for the staff of the division which represents the interests of public utility customers and subscribers in commission proceedings, in the performance of their duties, in accordance with commission policies and guidelines. *This bill would specify that the attorney and executive director may be directed in their duties by a vote of the commission, as prescribed.* The bill would require the president to preside at all meetings and sessions of the commission. The bill, until January 1, 2003, would authorize the Governor to appoint up to 2 advisers for each member of the commission upon the request of the commission member and would prohibit the total number of advisers exempt from civil service from exceeding 10. The bill would require the commission to seek funding for staffing in accordance with that appointment provision through the annual Budget Act.

The people of the State of California do enact as follows:

1 SECTION 1. Section 305 of the Public Utilities Code
2 is repealed.

3 SEC. 2. Section 305 is added to the Public Utilities
4 Code, to read:

5 305. The Governor shall designate a president of the
6 commission from among the members of the commission.
7 The president shall direct the executive director, the
8 attorney, and other staff of the commission, except for the
9 staff of the division described in Section 309.5, in the
10 performance of their duties, in accordance with
11 commission policies and guidelines. The president shall
12 preside at all meetings and sessions of the commission.



1 SEC. 3. Section 307 of the Public Utilities Code is
2 amended to read:

3 307. (a) The commission may appoint as attorney to
4 the commission an attorney at law of this state, who shall
5 hold office during the pleasure of the commission.

6 (b) The attorney shall represent and appear for the
7 people of the State of California and the commission in all
8 actions and proceedings involving any question under
9 this part or under any order or act of the commission. If
10 directed to do so by the president, *except as otherwise*
11 *directed by vote of the commission*, the attorney shall
12 intervene, if possible, in any action or proceeding in
13 which any such question is involved.

14 (c) The attorney shall commence, prosecute, and
15 expedite the final determination of all actions and
16 proceedings directed or authorized by the president,
17 *except as otherwise directed or authorized by vote of the*
18 *commission*, advise the commission and each
19 commissioner, when so requested, in regard to all matters
20 in connection with the powers and duties of the
21 commission and the members thereof, and generally
22 perform all duties and services as attorney to the
23 commission that the president, *or vote of the commission*,
24 may require of him.

25 SEC. 4. Section 308 of the Public Utilities Code is
26 amended to read:

27 308. (a) The commission shall appoint an executive
28 director, who shall hold office during its pleasure. The
29 executive director shall be responsible for the
30 commission's executive and administrative duties and
31 shall organize, coordinate, supervise, and direct the
32 operations and affairs of the commission and expedite all
33 matters within the commission's jurisdiction.

34 (b) The executive director shall keep a full and true
35 record of all proceedings of the commission, issue all
36 necessary process, writs, warrants, and notices, and
37 perform such other duties as the president, *or vote of the*
38 *commission*, prescribes. The president may authorize the
39 executive director to dismiss complaints or applications

1 when all parties are in agreement thereto, in accordance
2 with rules that the commission may prescribe.

3 (c) The commission may appoint assistant executive
4 directors who may serve warrants and other process in
5 any county or city and county of this state.

6 SEC. 5. Section 309.1 of the Public Utilities Code is
7 amended to read:

8 309.1. (a) The Governor may appoint up to two
9 advisers for each member of the commission upon the
10 request of the commission member. Each adviser shall
11 receive a salary fixed by the commission with the
12 approval of the Department of Personnel
13 Administration. The commission shall seek funding for
14 staffing in accordance with this section through the
15 annual Budget Act. The total number of advisers exempt
16 from civil service may not exceed 10.

17 (b) This section shall remain in effect only until
18 January 1, 2003, and as of that date is repealed, unless a
19 later enacted statute, that is enacted before January 1,
20 2003, deletes or extends that date.

21 SEC. 6. Section 309.1 is added to the Public Utilities
22 Code, to read:

23 309.1. (a) The Governor may appoint one adviser for
24 each member of the commission upon the request of the
25 commission member. Each adviser shall receive a salary
26 fixed by the commission with the approval of the
27 Department of Personnel Administration. The total
28 number of advisers exempt from civil service may not
29 exceed five.

30 (b) This section shall become operative on January 1,
31 2003.
